The Position and Role of the Village Council in Making Village Regulations in Dawuhan Kulon Village, Banyumas

Abstract

Village Council (BPD) plays an important role in the formation of village regulation (Perdes). Strengthening the role of BPD in legislation is an effort to improve the quality of village regulation products. This is outlined in Article 61 Village Law, BPD is an institution that embodies democracy in the administration of village governance that functions to accommodate and channel community aspirations, carry out the task of supervising the performance of the Village Head, and together with the Village Head, discuss and agree on the draft village regulation in Dawuhan Kulon Village during 2020-2023 was 24 Perdes's. One person was purely an initiative for BPD. This research shows that the Dawuhan Kulon BPD, in its role in the initiative to create village regulations, has not been optimal, as seen from the number of Perdes produced. BPD's position in carrying out aspirations is carried out through community activities. BPD places itself as an extension of the village community. Activities are carried out to socialize information on village development, accommodate community aspirations for village regulations, and agree with the Village Head. Recommendations from this research are formulated such that the community is aware that village regulation is a legal product for the benefit of the community; therefore, the community also needs to be involved. The BPD should socialize with its citizens through Rukun Tetangga meetings if there will be discussions and the creation of Perdes.

Introduction

Villages are a form of government that spearhead the success of services, governance, and development. Villages can exercise broad powers to regulate and manage government affairs based on the principles of autonomy and assistance tasks.¹ The position of the village and its role have a more sovereign, large, and broad role in organizing and managing the village.² In developing the village, the Village Head and BPD have a close relationship. The Village Head was responsible for organizing the Village Government, carrying out Village Development, fostering the village community, and empowering the village community. Village autonomy is original, unanimous, and complete, and is not a gift from the government.³

According to Law No. 6/2014 on Villages, the Village Consultative Body (BPD) has the authority to discuss and agree on drafting village regulations with the village head. In addition, the BPD is tasked with accommodating and channeling the aspirations of the village community and supervising the performance of the Village Head. Village regulations play a strategic role in driving village governance and development.⁴

In exercising this authority, village administration is carried out based on the principles of a) legal certainty, b) orderly administration, c) orderly public interest, d) openness, e) proportionality, f) professionalism, g) accountability, h) effectiveness and efficiency, i) local wisdom, j) diversity, and k) participatory".⁵

The village government is organized under the leadership of a Village Head and his assistants (village officials), representing the village community for relations out and into the community concerned.⁶ The village government has the tasks of fostering the life of the village community, fostering the village economy, maintaining peace and order in the village community, reconciling community disputes in the village, proposing draft village regulations, and stipulating them as village regulations with the Village Consultative Body.⁷

The importance and strategic position and role of the BPD, its existence is regulated by Law No. 6/2014 on Villages,

1. Article 54 paragraph (1): "The Village Consultative Meeting is a consultative forum attended by the Village Consultative Body, the Village Government, and elements of the Village community to deliberate on strategic matters in the administration of the Village Government."
2. Article 61: The BPD is an institution that embodies democracy in the implementation of village governance, which functions to accommodate and channel the aspirations of the community, carry out the task of monitoring the performance of the Village Head, and together with the Village Head discuss and agree on Draft Village Regulations.

Village regulations are laws and regulations stipulated by the Village Head after being discussed and agreed upon with the BPD. Village regulations are the legal framework for policy in the implementation of governance and development in the village scope.⁸ The Village Government and BPD are the lowest government structures that directly interact with the community. Implementation and development in the village are aimed at improving the standard of living and

welfare of the community through the establishment of policies, programs and activities that are in accordance with the main problems and priority needs of the community.⁹

BPD is a partner of the village government and supports each other in deliberating and discussing development regulations at the village level.¹⁰ Considering the importance and strategic role of BPD in relation to the Village Head and its role as a community aspiration body, this study will discuss the position and role of BPD in Village Regulations.

Basically, the BPD has the authority to establish village regulations together with the Village Head, accommodate, and channel community aspirations; therefore, the BPD as a consultative body originating from the village community, in addition to carrying out its function as a bridge between the Village Head and the village community, must also carry out its main function, namely the function of representation.¹¹

Currently, Dawuhan Kulon Village is developing several infrastructures as legal references to keep pace with the growing needs and development. One of the functions of BPD is to carry out its function as a village legislative body. Therefore, the BPD must be able to carry out this function in making village regulations accommodate the aspirations of the community.

Research Problems

The problem formulations used in this study are as follows :

1. What is the position and role of the BPD as a legislative body and carrying out community aspirations in the preparation of the Perdes in Dawuhan Kulon Village?
2. What are the constraints of BPD in making Perdes in Dawuhan Kulon Village?

Research Methods

The approach used in this research is a juridical sociological approach, namely research that emphasizes the symptoms that arise in society by researching primary data in the field, which is carried out by looking at the symptoms that arise in the object of research, using descriptive qualitative methods with an inductive approach, and analyzing them through three stages: data reduction, data presentation, and conclusion drawing. The object of this study is the Village Government, especially the Village Consultative Body (BPD) as a partner of the Village Head in establishing Village Regulations.

Discussion

1. The position and role of the BPD as a legislative body and executing community aspirations in the making of des in Dawuhan Kulon Village.

The Village Law provides autonomy to the village government in organizing its own government to facilitate the development process and improve the welfare of the village itself.¹² The Village Consultative Body, or BPD, as it is called by another name, is an institution that carries out government functions, whose members are representatives of the village population based on regional representation and are determined democratically.¹³ Normatively, the position and role of the BPD is regulated by Law No. 6/2014 on Villages in Article 62, which states that the BPD has the right to 1) propose draft village regulations, 2) ask questions, 3) submit proposals and/or opinions, 4) elect and be elected, and 5) receive benefits from the APBD. Law has a close relationship with the political theory of law.¹⁴

The implementation of the BPD's authority as described in the 2006 Banyumas Regency Regional Regulation, Article 11, states: (a) Discussing draft village regulations together with the Village Head; (b) Supervising the implementation of village regulations and Village Head regulations; (c) proposing the appointment and dismissal of the Village Head; (d) Forming a Village Head election committee; (e) exploring, accommodating, collecting, formulating, and channeling community aspirations; and (f) developing rules of procedure for the Village Consultative Body.

The role of the BPD is regulated in Article 35 of Government Regulation No. 72/2005, which confirms that drafts of village regulations come from both the village government and BPD. The participation of the Village Head and BPD in the drafting process of the village regulations demonstrates the existence of democratic life in the village. In Banyumas, the role of BPD is regulated in District Rules No. 13/2006, Article 10, which reads "The BPD functions to establish Village Regulations together with the Village Head, to accommodate and channel the aspirations of the community".

Based on this analysis, the BPD basically has the main tasks of: 1) formulating regulations (legislating function) needed by the village, which will be ratified by a decree of the Village Head; 2) together with the Village Head making the Village Financial Revenue and Expenditure Budget (budgeting function); and 3)

supervising the village executive (Village Head and his apparatus) in the implementation of daily governance (controlling function).¹⁵

The drafting of the village regulations must fulfill the validity and create order. Meanwhile, according to Mochtar Kusumaatmadja, the main purpose of the law is to create order and achieve justice.¹⁶ Thus, the BPD functions to establish village regulations together with the Village Head, accommodates and channels the aspirations of the community, and must understand the principles of making village regulations.¹⁷

BPD, as an institution that embodies democracy in village governance, has a legal influence on the establishment of the village regulations. The legal system must be a force that balances conflicting values in society.¹⁸ The legal system that regulates the relationship between individuals both materially and formally provides an opportunity for the disturbed balance to adjust to the new environment as a result of these changes.¹⁹ BPD has a strategic function to establish village policy and supervise the village government as a supervisory body.²⁰ However, it has not been able to perform its role properly in discussing village regulations.²¹

This is in accordance with the function of BPD: To protect, namely, maintaining the preservation of customs that live and develop in the village concerned as long as it supports the continuity of development. The function of BPD as a partner of the village government is as follows:

- a. legislation, namely formulation/making and stipulating Village Regulations along with the Village Government;
- b. supervision covers the implementation of Village Regulations, Village Budget, and decisions of the Village Head; and
- c. accommodating the aspirations of the community, namely, handling and channeling aspirations received from the community to authorized officials or agencies.

The realization of village democracy is emphasized in Article 11 of Government Regulation No. 72/2005 on villages. BPD has a strategic position in realizing village democracy. The realization of democracy in the village formed the Village Consultative Body in accordance with the culture that developed in the

village concerned, which serves as a legislative and supervisory body in terms of the implementation of village regulations, revenue and expenditure budgets, and decisions of the Village Head.²² Among the functions of legislative bodies, such as the BPD, the most important is to determine policies, make legislation, and control the executive body in accordance with the policies that have been set.²³

The function of BPD is based on Regional Regulation of Banyumas Regency No. 13/2006 Article 10 states that the Village Consultative Body has the function of establishing Village Regulations together with the Village Head, accommodating and channeling the aspirations of the community. Based on this function, BPD is the embodiment of a consultative body originating from the village community, and in addition to carrying out its function as a liaison between the Village Head and the village community, it must also carry out its main function, namely the function of representation.²⁴

Democratization in Dawuhan Kulon village was carried out to determine whether BPD in making and channeling the aspirations of the community has been implemented. Based on research data submitted by Mr. Carik, as many as 23 village regulations have been promulgated from 2020 to 2023 in Dawuhan Kulon. Of the 23 Village Regulations, 21 initiatives are from the Village Head and the rest are from the chart, as follows:

Based on these data, the position and role of BPD in the formation of village regulations in Dawuhan Kulon Village during 2020-2023 are as many as 24 Village Regulations. Purely an initiative for BPD (1) One Village Regulation. This shows that in BPD Dawuhan Kulon, Kedung Banteng District, the role of Village Regulations has not been optimal when viewed from the number of village regulations produced. His position in carrying out the role of BPD is quite good in carrying out aspirations. This is done by BPD members by participating in RT meeting activities. On this occasion, BPD positioned itself as an extension of the village community. The activities carried out are disseminating village development information that is being planned to accommodate the aspirations of the community towards the village regulations to be made, and socializing the perdes that have been agreed upon together with the Village Head.

2. BPD Constraints in Making Perdes in Dawuhan Kulon Village

Based on research supported by field observations, data were obtained from the head of BPD, that the working period of BPD is six years, the number of BPD members is seven, consisting of five people from high school education, one junior high school, and one bachelor's degree, if the average BPD education is Senior High School. During his time as a member of the BPD, there has never been a briefing on making perdes. Based on these data, BPD raises obstacles in making village regulations for implementing democratization in Dawuhan Kulon Village, including:

- a. BPD members for every period of change. So that to be able to carry out its functions, it is necessary to strengthen BPD membership;

- b. Village regulations are the result of democratization, but it is not easy to sit between the Village Government, BPD and Residents to discuss village consultative meetings; and
- c. Increases in regulations to keep pace with the demands of services and village development. This must be balanced with the quality and education of BPD.

This obstacle is in line with the results of research conducted by Al Mukri, Alfiandra, and Sri Artati Waluyati, there are three factors causing the ineffective role of BPD in the preparation of village regulations. These factors are:

- a. Resource factors: BPD membership does not fully have the ability to draft village regulations, there is no special training for drafting village regulations, and no budget or funds are allocated for drafting village regulations;
- b. Innovation factor: BPD's low creativity in exploring community aspirations in drafting village regulations; and
- c. Organizational adaptation factors: Lack of socialization in the community at every stage of village regulation preparation and BPD membership has not been too close to the community.²⁵

According to Nurcholis, to overcome these obstacles, villages can make village regulations on the procedures for making village regulations in the form of regulations issued by the village government as districts implement regional regulations. Village regulations are set by the Village Head, together with the BPD. Village regulations are formed within the framework of the village government, which is a further elaboration of higher laws and regulations by considering the socio-cultural conditions of the local village community.²⁶ The formation of law should be directed at the nature of the law (legal truth).²⁷ Village regulations must describe the purpose of the Constitution as the basis for the constitution of statehood.²⁸

Conclusion

The main tasks of BPD are: 1) formulating regulations (legislating functions) needed by the village, which will later be ratified by the Village Head Decree; 2) together with the Village Head to make a Village Financial Revenue and Expenditure Budget (budgeting function); and 3) supervising the village executive (Village Head and his apparatus) in the implementation of daily governance (controlling function). This task shows that the role of BPD in Law No. 6 of 2014

concerning Villages in the explanation of Article 1 number 4 of the Village Law One of the elements of village government administration and Article 35 of Government Regulation Number 72 of 2005 regulates the Draft Village Regulation from both parties, both from the Village Government and from BPD. In Banyumas Regency, the role of BPD is regulated in Regional Regulation Number 13 of 2006, article 10 which reads "BPD functions to establish Village Regulations together with the Village Head, accommodate and channel the aspirations of the community."

The position and role of BPD in the formation of village regulations in Dawuhan Kulon Village during 2020-2023 are 23 village regulations. Purely, an initiative from BPD (1), namely village regulations on clean water. This shows that BPD Dawuhan Kulon, Kedung Banteng District, the role of the initiative to create village regulations, has not been optimal when viewed from the number of village regulations produced. Its position in carrying out the role of BPD is quite good, namely placing itself as an extension of the hands of the village community, The activities carried out socialize information on village development that is being planned to accommodate community aspirations for village regulations to be made. socializes with the community.

Suggestion

The community must be aware that Village Regulations are legal products for the benefit of the community, and that the community should be directly involved in making village regulations. The People's Consultative Body, as the aspiration of the community, should socialize its citizens through household meetings if there is discussion and making of Village Regulations.
